Please nominate a rebate tier based on your estimated annual taxable income. The income thresholds below are effective from **1 July 2026**. If at any stage you want to nominate a new rebate tier or stop receiving the Australian Government Rebate as a reduced premium, you must notify Frank as soon as possible.

**Note:** Single parents and couples (including de facto couples) are subject to the family tiers. For families with children, the thresholds are increased by \$1,500 for each dependent child after the first.
